Event name: COMPOSITES MEETINGS 2023 (referred to as the "Event"):

1/ ORGANIZATION The Event is organized by abe - advanced business events, a limited company with a stated capital of 50000 Euros, whose registered head office is located at 10, rue de La Rochefoucauld CS 50300 - 92513 Boulogne-Billancourt, France, hereafter referred to as the Organizer.

2/ PURPOSE
